Subject:-Compassionate appointments under Jammu and Kashmir Rehabilitation Assistance Scheme- 2022.

CIRCULAR

Whereas, the General Administrative Department, J&K vide S.O. No 429 dated 06/09/2022 issued notification and introduced new scheme for making compassionate appointments in the Govt. departments and is called as **Jammu and Kashmir Rehabilitation Assistance Scheme, 2022;**

Whereas, the Govt. has repealed SRO-43 of 1994 and replaced it with S.O. No 429 dated 06/09/2022 and made it applicable from the date of notification in official gazette;


Whereas, the General Administrative Department vide Circular No 31-JK(GAD) of 2022 dated 08/09/2022 issued instructions to Autonomous Bodies, Public Undertakings/ Government Companies in UT of J&K, where SRO 43/ 1994 is currently in operation shall proceed to adopt the J&K Rehabilitation Assistance scheme, 2022 forthwith with the approval of the respective competent authorities namely Governing Bodies, Board of Directors etc;

Whereas, above mentioned organizations were also directed to take immediate measures for adoption of J&K Rehabilitation Assistance Scheme 2022 in respective organizations and set up a dedicated portal for the electronic receipt and disposal of applications for making compassionate appointments under the said scheme;

Whereas, the Administrative Department vide communication No HUD-LSG0ULBK/9/2024(E-7477530) dated 02/09/2024 has intimated that a dedicated portal under RAS, 2022 has been developed for Urban Local Bodies, Jammu/ Kashmir and portal is live now for public/ official use for ULB, Jammu / Kashmir, the URL of which is <https://jansugam.jk.gov.in>;

Now, it is impressed upon all the Chief Executive Officers/ Executive Officers to advise all the applicants, who have already applied under RAS, 2022, on portal of GAD or have not yet applied to apply afresh on the dedicated portal set up by the Housing & Urban Development Department for making compassionate appointments under RAS, 2022.
